


















































Guarantees : main exclusions

- Exclusion of the consequences and relapses of sickness contracted prior to the insurance period except in the case of absence of treatment within the 6 months preceding the affiliation
- Possibility of examining the medical file

- Beyond : medical selection



- Coverage of « recreational » sports




