I understand and comply the Regulation (EU) 2016/679 (General Data Protection Regulation) in the current version of the OJ L 119, 04.05.2016; cor. OJL 127, 23.5.2018 [General Data Protection Regulation \(GDPR\) – Official Legal Text \(gdpr-info.eu\)](#) – and specifically commit to the following (*Note: These examples do not represent an exhaustive list*):

- **I will not share** the exchange participant's complete application form, i.e., any part or excerpt thereof, to any third party, including Rotarians, non-Rotarians, or organizations that are not directly part of the contract between the two named districts or Multi Districts.
- **I will maintain** the confidentiality of participants' personal information, except for the following examples (*non-exhaustive list*)
 - medical data to physicians, hospital, or health units in case of sickness or accident of the participant,
 - medical administration of the school educating the participant,
 - school reports and data to the school administration hosting the participant,
 - essential medical record information can and must be shared with the host club YEO and the hosting families. This includes f.e. allergies, regular use of prescribed medication, chronic conditions, and situations where the specific medical information is of relevant interest or need,
 - introduction letters and photos of the application, family home address to the host club YEO, the host club counselor, and the different host families,
 - for legal purpose, to police, court, or legal state authorities – when there are well-founded, legitimate grounds concerning a specific personal situation.
- **I will inform** the recipients that it is strictly forbidden to share personal data received via the Rotary youth exchange program from European RYE sources. No name and/or related personal data can be shared, even in a report to Rotary International or any other company or organization or individuals. Here, the identity must remain anonymous.
- **I understand** that name and address can be shared f.e. sports clubs, cultural associations, and travel organizations with the individual's agreement or legal permission first.
